It provides subscribers with up to 3 on-site service visits per year to cover installs, maintenance, repairs, upgrades, add-ons and training on up to 3 computers, 3 printers, and attached peripherals & accessories. It also includes up to 12 technical support issues and entitles users to 20% discounts on other specific HJR SOFTWARE services.

**On-site Service:** Each ePASS service visit consists of up to one (1) hour of on-site inspection, maintenance, training and/or repairs at your home or office where the equipment is located. Any on-site visit that takes more than two hours is subject to being billed at the then effective HJRS On-site Repair Service rates minus the one hour covered by the ePASS and less a 20% discount for having the ePASS. If your equipment requires off-site repair, such as the use of HJRS' Depot Repair Service, the first hour is included and the remaining time may be charged at the then effective rate less a 20% discount. One issue per month can be covered by the ePASS. Additional technical support issues per month will be billed at the then effective HJRS Technical Support Service rates less a 20% discount for having the ePASS. ePASS customers do not require advance Technical Support deposit fees. After the twelfth technical support, each support is billed at the discounted rate. Remote Technical Support requires the advance purchase of an annually renewable HJRS Remote Access License fee of \$30/yr/device capable of receiving remote support and is automatically renewable. License fees may be due at the time the ePASS renews or around January 26th of each year.

Non-discounted Items: Purchased Computers, Software, Parts, Supplies, Tools, Accessories, and any items sold via HJR SOFTWARE's e-Store, u-Store, etc. are not part of the ePASS and NO DISCOUNTS will be applied to any of these items as a result of having the ePASS. HJRS' Programming & Development Services, HJRS' Internet Services, including but not limited to Website Hosting, Domain Name Registration, Advertising & Listing Services, Search Engine Optimization Services, Website Development Services, etc. are also not covered or discounted by the ePASS unless the services were sold to you as a part of a package or as a result of bundling services together.

Cancellation: The service can be canceled if HJR SOFTWARE does not perform any services for you while your ePASS is activated. No refunds of previously due payments will be provided nor will any previously due payments be waived. To cancel services, notify HJRS in writing either via U.S. mail or email. If services have been provided to you under the ePASS during the current yearly term, you remain obligated for the full cost of the ePASS service for that yearly term even if you elect to cancel the ePASS. If you elect to cancel the ePASS after receiving services under the ePASS, the cancellation cost to you will be the remaining monthly payments that have not yet been received by HJR SOFTWARE along with a \$35.00 early termination fee and any payment collection service payments encountered.
